- NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Northern India College of Education, Plot No. 451-453/2, Vilalge- Bhadadi Rajputana, Post office- Daulatpur, Town/city- Rooskee, District-Haridwar- 248402, State- Uttarakhand for conduction of B.Ed.  - 1. The institution shall comply with the various other norms and standards prescribed in the NCIE Regulations, as amended from time to time.
 - II. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
 - III. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

V. Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society/trust, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated time.
